AMENDMENT 2 TO
PUBLIC WORKS AGREEMENT

PROJECT: CITY WIDE “AS -NEEDED” CARPENTRY SERVICES

THIS AMENDMENT 2 TO PUBLIC WORKS AGREEMENT (hereinafter “Amendment”), dated April 22, 2026 for identification purposes, is made and entered into by and between the CITY OF OCEANSIDE, a municipal corporation, hereinafter designated as "CITY", and BOTSFORD CONSTRUCTION, INC., hereinafter designated as "CONTRACTOR."

RECITALS

WHEREAS, CITY and CONTRACTOR are the parties to that certain Public Works Agreement dated October 1, 2022 and Amendment 1 dated June 26, 2024, hereinafter referred to as the “Agreement,” wherein CONTRACTOR agreed to provide certain services to the CITY as set forth therein;

WHEREAS, the parties desire to amend the Agreement to provide for changes and/or modifications to the compensation for an additional scope of work.

AMENDMENT

NOW, THEREFORE, the parties hereto do mutually agree that the Agreement shall be amended as follows:

1. Section 10, Compensation, shall be amended by adding the following:

CONTRACTOR’s compensation for additional carpentry services performed in accordance with this Agreement is based on the scope of work set forth in Exhibit “A” attached hereto and by this reference made part of this Agreement. CONTRACTOR’s additional compensation shall not exceed \$306,500 (\$276,500 including a \$30,000 contingency) for a new total agreement price not to exceed \$1,609,884.54, (original contract price of \$275,000 plus renewal amounts of \$296,175, \$311,279.93, and \$320,929.61, plus \$100,000 for Amendment 1, and the additional amount for Amendment 2 of \$306,500).

2. Except as expressly set forth in this Amendment, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.


AS-NEEDED CARPENTRY SERVICES

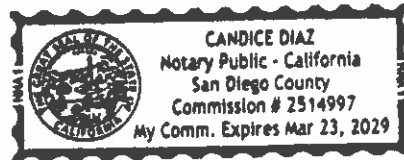
