Dear Ms. Geller:

Congratulations! Your organization has been selected to receive a grant of \$ 100,000 from Preserve Calavera. These funds are provided at the recommendation of Preserve Calavera 's Board of Directors and by the approval of The San Diego Foundation's Board of Governors for the continuation of the GoSide Shuttle service in Oceanside until 1/1/2026. These funds will cover expenses for this project from the time current funding is exhausted approximately November 1,2025 up until funding is in effect for the next calendar year. These funds are only to be used toward the costs of this service during this specified time period. In the future, please refer to this as OGHGERF Project 1-10 GoSide Shuttle.

The period for this grant is from receipt of funds to anticipated project completion by January 1,2026. .An initial report will be due on March 1, 2026 . In your initial report, please inform us of your successes and challenges with this project, and any other issues that have occurred related to system performance and results. Our focus is on long-term GHG reductions so our interest is in how much GHG emissions have been reduced by this project. Any lessons learned that would help us improve future projects like this is also appreciated. Report Guidelines will be sent to you electronically. To be eligible for future funding you must submit your report as requested. It is anticipated that this initial report will also be your only report. If circumstances change, we will evaluate modifying the terms of this agreement.

Under the guidelines of both Preserve Calavera and The San Diego Foundation grant funds may be expended only for charitable, scientific, literary, or educational purposes. This grant is made only for the purposes stated in this letter and it is understood that these grant funds will be used for such purposes. It is also understood that no variances will be made for the purpose of the grant without prior written approval by Preserve Calavera.

Any grant funds not expended for the purpose of the grant will be returned to The San Diego Foundation .OGHGERF Fund.

These funds will be transmitted to the city of Oceanside, in the manner that you specify, with initial payment by October 15, 2025
