NOTICE IS HEREBY GIVEN that the **City Council** of the City of Oceanside will conduct a **PUBLIC HEARING** on **WEDNESDAY, JANUARY 14, 2026 AT 6:00 PM**, or as soon thereafter as possible, in the Council Chambers of the Civic Center, 300 North Coast Highway, Oceanside, California, 92054 to consider the following:

A public hearing as required by Section 147(f) of the Internal Revenue Code of 1986 will be held with respect to a proposed plan of finance that includes the issuance and reissuance from time to time, by the California Municipal Finance Authority (the "Authority"), of one or more series of revenue bonds pursuant to section 142(a)(7) of the Internal Revenue Code of 1986, as amended, in an amount not to exceed \$75,000,000 (together with a like amount of refunding obligations) (the "Bonds"), to finance or refinance the acquisition, construction, development and equipping of a 199-unit qualified residential rental project (the "Project") located on an approximately 6.11-acre parcel situated south of Oceanside Boulevard and the North County Transit District rail line, north/northwest of College Boulevard and the western terminus of Olive Drive, and east of Rancho del Oro Road in the City of Oceanside, California (the "City"). The Project is to be owned and operated by Olive Park Apartments I, LP, a California limited partnership, or another ownership entity to be created by Capstone Equities, LLC (the "Sponsor"), or an affiliate of the Sponsor (such limited partnership or other ownership entity, the "Borrower").

The Bonds and the obligation to pay principal thereof and interest thereon and any redemption premium with respect thereto do not constitute indebtedness or an obligation of the City, the Authority, the State of California or any political subdivision thereof, within the meaning of any constitutional or statutory debt limitation, or a charge against the general credit or taxing powers of any of them. The Bonds shall be a limited obligation of the Authority, payable solely from certain revenues duly pledged therefor and generally representing amounts paid by the Borrower.
