- 1. Section 8, Compensation is hereby amended to provide that the total compensation for all work performed in accordance with this amendment shall not exceed \$150,000, and for total compensation under the Agreement not to exceed \$600,000.
- 2. Except as expressly set forth in this Amendment, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.
