

**CITY OF OCEANSIDE
AMENDMENT 4 TO
PROFESSIONAL SERVICES AGREEMENT**

PROJECT: COLLECTION AGENCY AGREEMENT

THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (hereinafter "Amendment"), dated September 17, 2025 for identification purposes, is made and entered into by and between the CITY OF OCEANSIDE, a municipal corporation, hereinafter designated as "CITY", and STATES RECOVERY SYSTEMS, INC., hereinafter designated as "CONSULTANT."

RECITALS

WHEREAS, City and Consultant are the parties to that certain Professional Services Agreement dated September 25, 2019, hereinafter referred to as the "Agreement", wherein Consultant agreed to provide certain services to the City as set forth therein;

WHEREAS, Amendment 1 to the Agreement, dated September 14, 2022, extended the term of the Agreement to September 25, 2023;

WHEREAS, Amendment 2 to the Agreement, dated September 13, 2023, extending the term by one (1) year pursuant to the original terms in the Agreement to September 25, 2024 and adding three (3) optional one-year extensions;

WHEREAS, Amendment 3 to the Agreement exercised the first of the three additional extensions by extending the Agreement by one year to September 25, 2025; and

WHEREAS, City and Consultant wish to exercise the second of the three additional extensions by extending the Agreement by one year to September 25, 2026;

AMENDMENT

NOW, THEREFORE, as set forth herein, the parties hereto do mutually agree that the Agreement, Section 8 – Timing Requirements, shall be amended as follows:

TIMING REQUIREMENTS

1. The term of the agreement is extended by one (1) year changing the expiration date from September 25, 2025 to September 25, 2026.
2. The agreement may be extended in the sole discretion of the City, in one-year time increments for an additional one (1) year. Any such extension shall be in written amendment signed by both parties.

Collection Agency Agreement

3. Except as expressly set forth in this Amendment, the Agreement, as modified by Amendment 4, shall remain in full force and effect and is hereby ratified and reaffirmed.

SIGNATURES. The individuals executing this Amendment represent and warrant that they have the right, power, legal capacity and authority to enter into and to execute this Amendment on behalf of the respective legal entities of the CONSULTANT and the CITY.

IN WITNESS WHEREOF the parties hereto being duly authorized on behalf of their respective entities to execute this Amendment, do hereby agree to the covenants contained in the Agreement, including this Amendment and have caused this Amendment to be executed by setting hereunto their signatures on the dates set forth below.
