| Comments             | <p>Dear Mayor and City Council Members,</p> <p>I am writing to encourage the City Council to strengthen the Police and Fire Commission by ensuring it more fully reflects the diversity of Oceanside and the communities it serves.</p> <p>Oceanside has already recognized the value of broad community representation in other areas of civic life. The Housing Commission includes positions intended to bring specific community perspectives and lived experiences into the conversation. Public safety oversight deserves the same commitment to representation.</p> <p>The Police and Fire Commission plays a unique role in advising on public safety matters, reviewing community concerns, and helping build trust between residents and public safety agencies. For that reason, I believe the commission would benefit from membership requirements that ensure a cross section of Oceanside's neighborhoods, backgrounds, and lived experiences are represented.</p> <p>The City currently has a rare opportunity to move in that direction. With two seats becoming vacant, the Council can begin implementing these values immediately through its upcoming appointments while also considering longer-term changes to the commission's structure. These appointments offer an opportunity to broaden representation and strengthen public confidence in the commission's independence and effectiveness.</p> <p>This request is not about excluding former law enforcement professionals. Their experience can be valuable. Rather, it is about ensuring that no single perspective dominates a commission whose effectiveness depends upon public trust and broad community participation.</p> <p>The decisions made regarding these two vacancies will send a message about how Oceanside understands community oversight. | Comments             | <p>Dear Mayor and City Council members,</p> <p>Presently, the Police and Fire Commission and the Standing Oversight Committee have a significant percentage of former OPD employees (PFC 33% and starting in August SOC 50%). Also, the current chair, responsible for leading meetings, is a former OPD member. This current configuration creates a perception that oversight resembles a "rooster guarding the henhouse," raising doubts and undermining community trust rather than fostering it.</p> <p>Thus, it is crucial that the PFC and SOC demonstrate independence. Their composition should not give the impression that they are closely tied to the OPD, but rather that they serve as impartial bodies, reinforcing public confidence in oversight and accountability.</p> <p>I urged you to replace the two former Oceanside Police employees who are scheduled to rotate off the Police and Fire Commission with individuals who reflect Oceanside's diversity.
