RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OCEANSIDE, CALIFORNIA ACTING AS THE LEGISLATIVE BODY OF CITY OF OCEANSIDE COMMUNITY FACILITIES DISTRICT NO. 2023-1 (NORTH RIVER FARMS PUBLIC FACILITIES), CERTIFYING THE RESULTS OF THE APRIL 23, 2025, SPECIAL ELECTION

WHEREAS, the City Council (the "Council") of City of Oceanside (the "City"), acting as the legislative body of City of Oceanside Community Facilities District No. 2023-1 (North River Farms Public Facilities) ("CFD No. 2023-1" or the "District") called and duly held an election on April 23, 2025, within the boundaries of the District pursuant to Resolution No._____ for the purpose of presenting to the qualified electors within the District the propositions attached hereto as Attachment "A"; and

WHEREAS, there has been presented to the Council a certificate of the City Clerk canvassing the results of the election, a copy of which is attached hereto as Attachment "B";

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF OCEANSIDE HEREBY FINDS, DETERMINES, RESOLVES, AND ORDERS AS FOLLOWS:

- Section 1. Each of the above recitals is true and correct and is adopted by the legislative body of the District.
- Section 2. Propositions A and B presented to the qualified electors of the District on April 23, 2025, were approved by more than two-thirds of the votes cast at the election held for the District, and Propositions A and B have each carried. The Council, acting as the legislative body of the District, is hereby authorized to levy on the land within the District the special tax described in Proposition B for the purposes described therein and to take the necessary steps to levy the special tax authorized by Proposition B and to issue one or more series of bonds in an aggregate amount not to exceed \$25,000,000 as specified in Proposition A.
- Section 3. The City Clerk is hereby directed to record in the Office of the County Recorder within fifteen days of the date hereof a second amended and restated notice of special tax lien which
