# A RESOLUTION OF THE OCEANSIDE HARBOR DISTRICT BOARD OF DIRECTORS AMENDING RESOLUTION NO. 23-R0791-1 TO ADD ELECTRICITY AND WATER CHARGES TO SLIP RENTAL RATES

WHEREAS, the Oceanside Harbor District Board of Directors has reviewed rents and fees assessed for various activities and services provided in the District; and

WHEREAS, the Board desires to adjust certain rents and assessed fees as established in Harbor Resolution No. 23-R0791-1 ("Master Fee Resolution") to establish utility charges for slip renters in order to maintain the balance between a market competitive fee-based marina operation and a financially sound operational organization.

NOW, THEREFORE, BE IT RESOLVED by the Oceanside Harbor District Board of Directors that Harbor Resolution No. 23-R0791-1 is hereby amended to establish utility charges for slip renters in the Master Fee Resolution as follows:
