5. **Stadium Field has (7) Poles & (50) Musco 1500watt Lights**
6. **No work in Field 4 included at this time**
7. Includes disposal of existing Lamps and Ballast.
8. Existing conditions may not be to code; this proposal does not include bringing any existing conditions to code other than the work shown on the referenced drawings (if provided)

ITEM II-PAYMENT SCHEDULE: Payment of 100% for actual work completed due within 30 days of invoice date.


ITEM III-EXCLUSIONS: This proposal has no provisions for engineering, bonds, permits, testing, export of spoil, SDG&E fees, traffic control, removing or replacing any asphalt/concrete, saw cutting, or excavation of any material not reasonably possible to excavate with an E32 BOBCAT excavator. No electrical panel lighting controls, tie-ins, or final terminations inside of electrical rooms. *Additional repairs outside of lamps, ballasts, and capacitors. Field repair from getting a 100' lift to each light pole.*

ITEM IV-ATTORNEY'S FEES: If any matter under this proposal is referred to an attorney because of a dispute or default under the terms of this proposal, then the defaulting party agrees to pay the sum of reasonable attorney's fees, and any other costs involved in enforcing the terms of this proposal.
