PUBLIC WORKS AGREEMENT**

**PROJECT: 2022 ENCAMPMENT ABATEMENT AND RELATED LITTER  
REMOVAL SERVICES**

THIS AMENDMENT TO PUBLIC WORKS AGREEMENT (hereinafter "Amendment"), dated April 15, 2026 for identification purposes, is made and entered into by and between the CITY OF OCEANSIDE, a municipal corporation, hereinafter designated as "CITY", and Singh Group Inc. DBA MUNU LLC, hereinafter designated as "CONTRACTOR."

**RECITALS**

WHEREAS, CITY and CONTRACTOR are the parties to that certain Public Works Agreement dated April 18, 2022; Amendment 1 thereto, dated October 17, 2022; Amendment 2 thereto, dated May 9, 2023; Amendment 3 thereto, dated May 15, 2024; and Amendment 4 thereto, dated April 28, 2025; hereinafter referred to as the "Agreement," wherein CONTRACTOR agreed to provide certain services to the CITY as set forth therein;

WHEREAS, the parties desire to amend the Agreement to adjust the total compensation and extend the term of the agreement for an additional year beginning July 1, 2026 and ending June 30, 2027.

**AMENDMENT**

NOW, THEREFORE, the parties hereto do mutually agree that the Agreement shall be amended to increase the total compensation to \$4,164,586.

Except as expressly set forth in this Amendment, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.

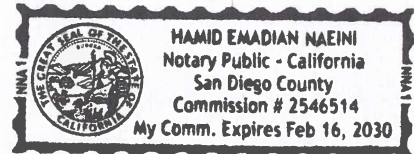
