and entered into by and between the CITY OF OCEANSIDE, a municipal corporatio	n,
hereinafter designated as "CITY", and MainStreet Oceanside, hereinafter designated	as
"CONSULTANT."	

RECITALS

WHEREAS, the City Council of the City of Oceanside ("City Council") approved a Professional Services Agreement with CONSULTANT in the amount of \$1,326,319 for implementation and management of a one-year pilot program for enhanced safety and security in Downtown Oceanside on September 28, 2022, hereinafter referred to as the "Agreement"; and

WHEREAS, the Measure X Citizens Oversight Committee endorsed the revised FY 2023-24 (Year 5) Spending Plan, which included continued funding for CONSULTANT to manage the enhanced safety and security program in downtown Oceanside, and recommended approval to the City Council, on August 2, 2023; and

WHEREAS, City Council approved Amendment 1 to the Agreement with CONSULTANT in the amount of \$1,881.766, modifying the Scope of Work and extending CONSULTANT's implementation and management of the enhanced safety and security program in downtown Oceanside for a period of 15 months on September 27, 2023; and

WHEREAS, the Measure X FY 2024-25 Spending Plan, which included continued funding for enhanced downtown safety and security, was approved by City Council as part of the CITY's FY 2024-2025 operating budget on June 5, 2024; and

WHEREAS, City Council approved Amendment 2 to the Agreement with CONSULTANT in the amount of \$1,366,108, modifying the Scope of Work and extending CONSULTANT'S implementation and management of the enhanced safety and security program in downtown Oceanside for a period of one year on December 12, 2024; and

WHEREAS, CITY and CONSULTANT desire to further amend the Agreement to extend the program for implementation and management of enhanced safety and security in downtown Oceanside by CONSULTANT for an additional one-year period.

NOW, THEREFORE, the parties hereto do mutually agree that the Agreement shall be amended as follows:

- 1. Section 8 is amended as follows: CONSULTANT'S compensation for all work performed in accordance with this Agreement for the one-year period covered by this Amendment shall not exceed the total contract price of \$1,366,108. The effective date of this Amendment 1 shall be January 1, 2026 and terminate on December 31, 2026, unless terminated earlier as provided in the Professional Services Agreement.
- 2. The Scope of Work referenced in Section 1 and incorporated as Attachment A to Amendment 1 of the Agreement is fully replaced by the Scope of Work included as Attachment A to this Amendment 3.
- 3. Except as expressly set forth in this Amendment 3, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.
