PROJECT: STREET MARKET MOBILE BARRIERS

THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (hereinafter "Amendment"), dated _____, 2026 for identification purposes, is made and entered into by and between the City of Oceanside, a municipal corporation, hereinafter designated as "CITY", and Meridian Rapid Defense Group, LLC hereinafter designated as "CONSULTANT."

RECITALS

WHEREAS, CITY and CONSULTANT are the parties to that certain Professional Services Agreement dated February 5, 2025, hereinafter referred to as the "Agreement", wherein CONSULTANT agreed to provide mobile barrier deployment services to the City;

WHEREAS, the CONSULTANT has been providing mobile barrier deployment services at the Morning and Sunset Markets since May 2025 to present; however, the Agreement expires on May 14, 2026;

WHEREAS, the parties are desirous of extending the term of the Service Agreement to allow continued mobile barrier deployment services at the Morning and Sunset Markets; and

WHEREAS, the parties desire to amend the Agreement, effective May 21, 2026 and extend the term of the Agreement for three (3) years as set forth herein.

AMENDMENT

NOW, THEREFORE, the parties hereto do mutually agree that the Agreement shall be amended as follows:

1. **SCOPE OF WORK**. This section shall be amended to specify an expiration date of **May 20, 2029**. All other verbiage shall remain the same within this section.
2. **COMPENSATION**. CONSULTANTS compensation for all work performed in accordance with Agreement, shall not exceed the total contract price of \$351,000 for the three-year term effective from May 21, 2026 through May 20, 2029.

3. Except as expressly set forth in this Amendment, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.

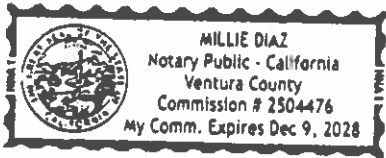
