Best practice strategies will be conducted to reduce the number of persons killed and injured in crashes involving alcohol and other primary crash factors. The funded strategies may include impaired driving enforcement, enforcement operations focusing on primary crash factors, distracted driving, night-time seat belt enforcement, special enforcement operations encouraging motorcycle safety, enforcement and public awareness in areas with a high number of bicycle and pedestrian crashes, and educational programs. These strategies are designed to earn media attention thus enhancing the overall deterrent effect. In addition, the department will participate in community collaboration and engagement activities to engage in conversations regarding traffic safety with community members.

1. PROBLEM STATEMENT

Describe the city, county, or jurisdiction this grant will impact.

The City of Oceanside expands 42 square miles, with a population of approximately 171,000 as of 2024. Based on population, Oceanside is the 29th largest city in the state of California and the 3rd largest city in San Diego County. The Oceanside Police Department (OPD) is responsible for traffic enforcement and all crash investigations on State Route 76 within the city limits, as well as city streets. Roadways throughout the City vary from major thoroughfares to rural roads. Financial assistance provided by previous Office of Traffic Safety (OTS) STEP grants, have allowed Oceanside to remain comparable to similar-sized cities in the OTS ranking of total fatal and injury crashes.

Describe the problem(s) to be addressed, supported by current and relevant crash data. (most recent calendar year data/stats).

Although OPD has made traffic-related accomplishments in recent years in some areas, there are undoubtedly still opportunities for improvement according to Oceanside's traffic statistics. Between 2017 and 2020, the number of fatal or injured victims of crashes decreased from 817 to 699, a decrease of over 14 percent. In recent years, these totals have fluctuated from 732 in 2021, to 776 in 2022, 699 in 2023.

Currently, the City's primary traffic concerns are motorcycle safety, speeding, and DUI (driving under the influence) related incidents.

Oceanside's motorcycle-involved traffic incidents statistics have become increasingly concerning in recent years as the City leads the state for motorcycle incidents for similar sized cities.

Speed is the primary cause of crashes in Oceanside, at approximately 28 percent.

As of 2024, there are 377 ABC (Alcoholic Beverage Control)-licensed businesses operating in Oceanside, which suggests that there are ample establishments available for drivers to visit prior to getting behind the wheel. Driving under the influence (DUI) education and enforcement efforts remain a focal point for the OPD. In 2024, there were 428 DUI arrests, with 47 percent being associated to a crash. Oceanside had 31 major injury/fatal crashes that resulted in our Multidisciplinary Crash Investigation Team (MAIT) being deployed to investigate, which is a 52 percent increase from 2023. Of those 31 crashes, there were 17 fatalities as a result of the injuries sustained. 11 of the 31 crashes (35 percent) involved at least one driver being under the influence of drugs and/or alcohol.

Annually, the OPD receive hundreds of traffic-related suggestions and complaints through official channels from concerned citizens. As a result, OPD is committed to continued implementation of traffic calming measures throughout the City. This will include checkpoints and various enforcement operations. As of 2024, there are six officers dedicated to vehicle code enforcement at our agency. Unfortunately, current staffing limitations do not permit the necessary amount of time for self-initiated enforcement.

OPD will support instructors for DUI Standardized Field Sobriety Testing (SFST), Advanced Roadside Impaired Driving Enforcement (ARIDE), and Drug Recognition Expert (DRE) courses to address a critical training gap in San Diego County. Currently, only two agencies in the county provide regular SFST instruction (San Diego Sheriff's Department and Chula Vista Police Department), and just one of those agencies (Chula Vista) offers regular instruction in ARIDE and DRE—and that training is held near the southern end of the county. This leaves a significant void in North County, where no agencies provide these essential courses on a regular basis. Our department already has certified instructors and POST/CHP-approved SFST and ARIDE courses in place; however, as a smaller agency with a part-time training staff, we lack the dedicated funding to staff and deliver these courses on a consistent basis. Our instructors are collateral assignments, meaning they must balance training responsibilities alongside their regular law enforcement duties, making outside support vital to sustain program delivery.

Additionally, San Diego County also has fewer Drug Recognition Experts (DREs) compared to other neighboring counties, further highlighting the need for expanded impaired-driving training opportunities. Since completion of SFST and ARIDE is a prerequisite to entering the DRE program, increasing the availability of these foundational courses directly supports the pipeline to develop more DREs in the region. The number of DRE Instructors in San Diego County is also significantly low, leading to our department's sole DRE Instructor being requested to teach ARIDE/DRE from other agencies throughout Southern California. OPD will provide accessible, high-quality training in areas of the county currently underserved, while building long-term enforcement capacity to better identify and remove impaired drivers from our roadways.

In addition to the life-preserving enforcement operations OPD would like to conduct, equipment will be invaluable to the traffic-focused efforts in Oceanside. Speed enforcement guns enable officers to effectively capture vehicle speed and penalize Oceanside's most egregious speeders. Other general checkpoint supplies and preliminary alcohol screening (PAS) device supplies will ensure that the goals of the grant can adequately be met.

Define the target population the grant intends to serve and how they are affected by the problem(s). Proactively considering Oceanside's future is important when discussing traffic-related issues. A substantial increase in the construction of multifamily residential dwellings, as well as commercial properties throughout the City will ultimately lead to an increase in the City's population. This will indisputably have an impact on Oceanside's vehicle and pedestrian traffic, and we take these factors into consideration as we determine objectives to focus on that ensure the upmost safety for our community.

OPD is committed to innovatively making the roadways of Oceanside safer for all commuters. The focus is not only to issue citations to dangerous drivers, but to also educate the public on best practices to keep themselves, their families, and their neighbors safe while driving each day. The partnership between OPD, the Oceanside community, and OTS will be vital in the reduction of vehicular incidents, specifically those related to speed and impaired driving.

3. METHOD OF PROCEDURE

A. Phase 1 – Program Preparation (1st Quarter of Grant Year)

- The department will develop operational plans to implement the "best practice" strategies outlined in the objectives section.
- Conduct all training needed to implement the program, in the first quarter.
- Purchase all grant related supplies and materials to implement the program, in the first quarter.
- Items with a unit cost of \$5,000 more (including tax and shipping) must comply with Buy America.
- In order to develop/maintain the "DUI BOLOs," research will be conducted to identify the "worst of
 the worst" repeat DUI offenders with a suspended or revoked license as a result of DUI
 convictions. The DUI BOLO may include the driver's name, last known address, DOB,
 description, current license status, and the number of times suspended or revoked for DUI. DUI
 BOLOs should be updated and distributed to traffic and patrol officers at least monthly.
- Implementation of the STEP grant activities will be accomplished by deploying personnel at high crash locations.

Media Requirements

Issue a news release approved by the OTS PIO announcing the kick-off of the grant by December 31 and after the grant is signed and executed, but no sooner than October 1, the start of the grant year. The kick-off release must be approved by the OTS PIO. If you are unable to meet the December 31 deadline to issue a kick-off press release, communicate reasons to your OTS grant coordinator and OTS PIO.

B. Phase 2 – Program Operations (Throughout Grant Year)

Media Requirements

The following requirements are for all grant-related activities:

- Send all media advisories, alerts, videos, graphics, artwork, posters, radio/PSA/video scripts, storyboards, digital and/or print educational materials for grant-related activities to the OTS PIO at pio@ots.ca.gov for approval and copy your OTS grant coordinator. Optimum lead time would be 7 days before the scheduled release but at least 3 business days prior to the scheduled release date for review and approval is appreciated.
- Send all PowerPoint presentations, online presentations and trainings for grant-related activities
 to the OTS PIO at <u>pio@ots.ca.gov</u> for approval and copy your OTS grant coordinator. Certified
 training courses are EXEMPT from the approval process.
- The OTS PIO is responsible for the approval of the design and content of materials. The agency
 understands OTS PIO approval is not authorizing approval of budget expenditure or cost. Any
 cost approvals must come from the OTS grant coordinator.
- Pre-approval is not required when using any OTS-supplied template for media advisories, news releases, social media graphics, videos or posts, or any other OTS-supplied educational material. However, copy the OTS PIO at pio@ots.ca.gov and your OTS grant coordinator when any material is distributed to the media and public, such as a news release, educational material, or link to social media post.
- If an OTS-supplied template, educational material, social media graphic, post or video is substantially changed, the changes shall be sent to the OTS PIO at pio@ots.ca.gov for approval and copy your OTS grant coordinator.
- News releases, social media posts and alerts on platforms such as NextDoor and Nixle reporting immediate and time-sensitive grant activities (e.g. enforcement operations, day of event highlights or announcements, event invites) are EXEMPT from the OTS PIO approval process. The OTS PIO and your OTS grant coordinator should still be notified when the grant-related activity is happening (e.g. car seat checks, bicycle rodeos, community presentations, DUI checkpoints, etc.).
- Enforcement activities such as warrant and probation sweeps, court stings, etc. that are embargoed or could impact operations by publicizing in advance are EXEMPT from the PIO

- approval process. However, announcements and results of activities should still be copied to the OTS PIO at pio@ots.ca.gov and your OTS grant coordinator with the embargoed date and time or with "INTERNAL ONLY: DO NOT RELEASE" message in subject line of email.
- Any earned or paid media campaigns for TV, radio, digital or social media that are part of a specific grant objective, using OTS grant funds, or designed and developed using contractual services by a subgrantee, requires prior approval.
- Social media posts highlighting state or national traffic safety campaigns (Distracted Driving Month, Motorcycle Safety Awareness Month, etc.), enforcement operations (DUI checkpoints, etc.), or any other grant-related activity such as Bicycle rodeos, presentations, or events, are highly encouraged but do not require prior approval.
- Submit a draft or rough-cut of all digital, printed, recorded or video material (brochures, posters, scripts, artwork, trailer graphics, digital graphics, social posts connected to an earned or paid media campaign grant objective) to the OTS PIO at pio@ots.ca.gov and copy your OTS grant coordinator for approval prior to the production or duplication.
- Use the following standard language in all press, media, and printed materials, space permitting: Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.
- Space permitting, include the OTS logo on all grant-funded print materials, graphics and paid or earned social media campaign grant objective; consult the OTS PIO and copy your OTS grant coordinator for specifics, format-appropriate logos, or if space does not permit the use of the OTS logo.
- Email the OTS PIO at pio@ots.ca.gov and copy your OTS grant coordinator at least 21 days in advance, or when first confirmed, a short description of any significant grant-related traffic safety event or program, particularly events that are highly publicized beforehand with anticipated media coverage so OTS has sufficient notice to arrange for attendance and/or participation in the event. If unable to attend, email the OTS PIO and coordinator brief highlights and/or results, including any media coverage (broadcast, digital, print) of event within 7 days following significant grant-related event or program. Media and program highlights are to be reflected in QPRs.
- Any news releases, work plans, scripts, storyboards, artwork, graphics, videos or any educational
 or informational materials that received OTS PIO approval in a prior grant year needs to be
 resubmitted for approval in the current grant year.
- For additional guidance, refer to the <u>OTS Grants Materials Approval Process Guidelines</u> and OTS Grants Media Approval Process FAQs on the OTS website.
- Contact the OTS PIO or your OTS grant coordinator for consultation when changes from any of the above requirements might be warranted.

C. Phase 3 – Data Collection & Reporting (Throughout Grant Year)

- 1. Prepare and submit grant claim invoices (due January 30, April 30, July 30, and October 30)
- 2. Prepare and submit Quarterly Performance Reports (QPR) (due January 30, April 30, July 30, and October 30)

 - Provide a brief list of activity conducted, procurement of grant-funded items, and significant media activities. Include status of grant-funded personnel, status of contracts, challenges, or special accomplishments.
 - Provide a brief summary of quarterly accomplishments and explanations for objectives not completed or plans for upcoming activities.
 - Collect, analyze and report statistical data relating to the grant goals and objectives.

4. METHOD OF EVALUATION

Using the data compiled during the grant, the Grant Director will complete the "Final Evaluation" section in the fourth/final Quarterly Performance Report (QPR). The Final Evaluation should provide a brief summary of the grant's accomplishments, challenges and significant activities. This narrative should also include whether goals and objectives were met, exceeded, or an explanation of why objectives were not completed.


