THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (hereinafter “Amendment”), dated \_\_\_\_\_, 20\_\_\_\_, for identification purposes, is made and entered into by and between the CITY OF OCEANSIDE, a municipal corporation, hereinafter designated as "CITY", and WEST YOST ASSOCIATES, hereinafter designated as "CONSULTANT."

**RECITALS**

WHEREAS, City and Consultant are the parties to that certain Professional Services Agreement dated March 10, 2021, Amendment 1 dated June 7, 2023, and Amendment 2 dated February 25, 2025, hereinafter referred to as the “Agreement”, wherein Consultant agreed to provide certain services to the City as set forth therein;

WHEREAS, the parties desire to amend the Agreement to modify the scope of work, extend the term of the agreement, and provide compensation therefor.

**AMENDMENT**

NOW, THEREFORE, the parties hereto do mutually agree that the Agreement shall be amended as follows:

1. Section 1, Scope of Work, shall be amended to reflect and include the additional work as described and outlined in the letter dated March 3, 2026, attached hereto and incorporated herein as Exhibit A.

2. Section 8, Compensation, shall be amended to reflect that all work performed in accordance with Amendment 3 shall not exceed \$534,035, for a total contract price not to exceed \$1,855,654.

3. Section 9, Timing Requirements, shall be amended to reflect that all work be completed in every detail to the satisfaction of the City by February 28, 2027.

4. Except as expressly set forth in this Amendment, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.

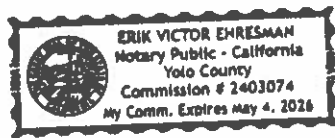

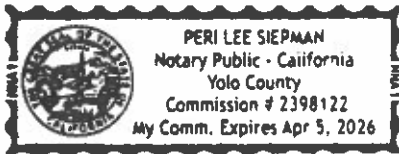
