## AMENDMENT NO. 1 TO PROPERTY USE AGREEMENT

This AMENDMENT NO. 1 TO PROPERTY USE AGREEMENT is made this <sup>17th</sup>day of <u>June</u> 2020 ("Amendment"), by and between the CITY OF OCEANSIDE, ("CITY") and WEST COAST TOMATO GROWERS, LLC, hereinafter referred to as ("PERMITTEE").

# RECITALS

WHEREAS, CITY and PERMITTEE entered into a Property Use Agreement ("Agreement") dated September 16, 2015, for use of 9.2 acres of vacant land more particularly described as being a portion of Lot 3 of the partition of Rancho Guajome ("PREMISES") situated in the City of Oceanside, County of San Diego, State of California; and

WHEREAS, CITY and PERMITTEE are desirous of extending the term of the Agreement for an additional five (5) years under the terms and conditions of the Agreement at the CITY's calculated fair market lease payment rate.

NOW, THEREFORE, in consideration of the covenants and conditions contained herein, the parties hereto agree to amend the Agreement as follows:

#### AGREEMENT

1. **SECTION 2: TERM,** Subsections 2.01. <u>Commencement</u> is hereby deleted in its entirety and replaced with the following language:

2.01 <u>Term</u>. The term of this Agreement for the PREMISES, is for an additional five (5) years effective July 1, 2020 and terminating June 30, 2025.

2. **SECTION 3: PROPERTY USE PAYMENT,** Subsection 3.02. <u>Initial Minimum Annual</u> <u>Property Use Payment</u> is hereby deleted in its entirety and replaced with the following language:

**3.02** <u>Initial Minimum Annual Property Use Payment</u>. The minimum annual property use payment for the first (1<sup>st</sup>) year of the extended term of this Agreement shall be Four **Thousand Sixty Dollars (\$4,060.00)** which shall be payable annually on or before the first (1<sup>st</sup>) day of July, without demand or invoice. For the convenience of this Agreement, minimum annual property use payment may be referred to as "Rent".

# REMAINDER OF PAGE SHALL BE LEFT BLANK

All other terms, conditions, covenants and provisions of the Agreement shall remain in 3. full force and effect. In the event of any conflict between the terms of the Agreement and this Amendment, the terms of this Amendment shall control.
