This change order provides for:

REMOVE AND REPLACE all existing wood flooring in lieu of salvaging and patching perimeter flooring, per City request; ten (10) additional calendar days have been added and no calendar days have been deleted.

PROVIDE videoing of existing sewer line inside the building to the sewer main to verify current conditions, per City request; no (0) additional calendar days have been added and no calendar days have been deleted.

PROVIDE coastal coating for corrosion prevention of HVAC equipment in accordance with directions from the vendor; no (0) additional calendar days have been added and no calendar days have been deleted.

UPGRADE small capacity split-system air conditioner unit breakers from 20A/2P to 40A/2P, and 2-pole, 30A fused NEMA3R with a 2-pole, 60A fused NEMA 3R in accordance with MEP Engineer submittal #22 response; three (3) additional calendar days have been added and no calendar days have been deleted.

REPLACE seven (7) single GFCI receptacles with quad GFCI receptacles, replace twelve (12) duplex receptacles with quad duplex receptacles, replace existing single-gang mud rings and electrical boxes to accommodate new quad receptacles devices, replace existing quad receptacles at six (6) locations to match updated specifications and finishes of new receptacles, and rework electrical wiring to be routed in the walls; three (3) additional calendar days have been added and no calendar days have been deleted.

DELETE Insta-Hot Water Heater (IWH1) from all gender restroom and run hot water from water heater in Kitchenette Area, per City Request; no (0) additional calendar days have been added and no calendar days have been deleted.

ADD five (5) interior wall scones at the lobby in accordance with Architect's response on submittal #22; three (3) additional calendar days have been added and no calendar days have been deleted.

REPLACE ordered, non-returnable exhaust fans with new exhaust fans to fit in space available in ceiling in accordance with RFI #21; original fans to be provided to the City; no (0) additional calendar days have been added and no calendar days have been deleted.

DESIGN shoring engineering for structural repairs, per City request; no (0) additional calendar days have been added and no calendar days have been deleted.

REPLACE and lower profile of existing skylight, per City request; no (0) additional calendar days have been added and no calendar days have been deleted.

REMOVE existing parapet/cripple wall at roof, clear debris, cover gaps, and provide smooth transition at roof in accordance with RFI #27; no (0) additional calendar days have been added and no calendar days have been deleted.

PROVIDE walking pads around HVAC units and supply fan for equipment maintenance safety in accordance with RFI #26; no (0) additional calendar days have been added and no calendar days have been deleted.
