THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (hereinafter "Amendment"), dated \_\_\_\_\_ 20\_\_\_\_, for identification purposes, is made and entered into by and between the City of Oceanside, a municipal corporation, hereinafter designated as "CITY", and ARDURRA GROUP, INC., hereinafter designated as "CONSULTANT."

**RECITALS**

WHEREAS, CITY and CONSULTANT are the parties to that certain Professional Services Agreement dated December 18, 2019, Amendment 1 dated November 2, 2022, and Amendment 2 dated December 11, 2025, hereinafter referred to as "Agreement", wherein CONSULTANT agreed to provide certain services to the CITY as set forth therein;

WHEREAS, the parties desire to amend the Agreement to extend the timing requirements and add compensation therefor.

**AMENDMENT**

NOW, THEREFORE, the parties hereto do mutually agree that the Agreement shall be amended as follows:

1. Section 7, Compensation, shall be amended to reflect that all work performed in accordance with Amendment 3 shall not exceed \$1,369,680 for a total contract price not to exceed \$3,198,000. All compensation shall be in accordance with the 2026 amendment request letter, dated February 6, 2026, attached hereto and incorporated herein as Exhibit A.
2. Section 8, Timing Requirements, shall be amended to reflect that all work shall be completed in every detail to the satisfaction of the CITY by June 30, 2028.
3. Except as expressly set forth in this Amendment, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.






