

**CITY OF OCEANSIDE  
AMENDMENT 01 TO  
PROFESSIONAL SERVICES AGREEMENT**

**PROJECT: Regional Task Force on Homelessness: Consultant Services for  
Implementation of Encampment Resolution Fund Project**

THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (hereinafter "Amendment"), dated July 1, 2025, for identification purposes, is made and entered into by and between the CITY OF OCEANSIDE, a municipal corporation, hereinafter designated as "CITY", and Regional Task Force on Homelessness (RTFH), hereinafter designated as "CONSULTANT."

**RECITALS**

WHEREAS, CITY and CONSULTANT are the parties to that certain Professional Services Agreement dated May 1, 2025, hereinafter referred to as the "Agreement," wherein CONSULTANT agreed to provide strategic planning, implementation, and technical support services for the City's Encampment Resolution Fund (ERF) program through Impact Group Consultants; and

WHEREAS, the original Agreement authorized compensation not to exceed \$100,000 for the period of May 1, 2025, through April 30, 2026; and

WHEREAS, the CITY desires to amend the Agreement to provide for continued Strategic Planning, Implementation, and Technical Support services to ensure uninterrupted Encampment Resolution Fund activities and extend the term of the Agreement; and

WHEREAS, the parties agree that this amendment is necessary to increase the contract funding and extend services to support ongoing ERF program implementation, staff training, communications, and leveraging existing resources, execution of the ERF Project through June 30, 2027.

**AMENDMENT**

NOW, THEREFORE, the parties hereto do mutually agree that the Agreement shall be amended as follows:

1. Section 7. COMPENSATION, is hereby amended to provide that the total compensation for all work performed in accordance with this amendment shall not exceed \$143,000, for a total agreement price not to exceed \$243,000.
