

**CITY OF OCEANSIDE
AMENDMENT TO
PROFESSIONAL SERVICES AGREEMENT FOR SAFETY AND LOSS
CONTROL SERVICES**

PROJECT: SAFETY AND LOSS CONTROL CONSULTANT SERVICES

THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (hereinafter "Amendment"), dated _____, 2026 for identification purposes, is made and entered into by and between the CITY OF OCEANSIDE, a municipal corporation, hereinafter designated as "CITY", and CITADEL EHS, hereinafter designated as "CONSULTANT."

RECITALS

WHEREAS, City and Consultant are the parties to that certain Professional Services Agreement dated December 8, 2022, hereinafter referred to as the "Agreement", wherein Consultant agreed to provide certain services to the City as set forth therein;

WHEREAS, the parties desire to amend the Agreement to provide for changes and/or modifications to the scope of work, compensation, and terms of the Agreement.

AMENDMENT

NOW, THEREFORE, the parties hereto do mutually agree that the Agreement shall be amended as follows:

1. Section 1, Scope of Work, shall be amended by adding approximately four (4) additional hours per week to the current schedule in order to provide services under the terms of the contract.

2. Section 7, Compensation, shall be amended to add the following:
CONSULTANT's additional compensation for the additional time described in this Amendment 1 shall not exceed \$40,000 annually for the remainder of optional two years of the current Agreement. CONSULTANT shall bill on a monthly basis, and monthly charges may be less, but shall not exceed \$16,000 in any given month in which agreed upon services are rendered. The Total Compensation under the Agreement, including Amendment 1, shall be \$691,000 (original contract amount of \$611,000 + \$80,000).

3. Section 14, shall be added to include **PROTECTION OF PERSONAL INFORMATION**. "Personal information" means information that identifies, relates to, describes, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer or household, as more fully defined in

SAFETY AND LOSS CONTROL SERVICES

California Civil Code section 1798.140. The CONSULTANT shall not collect any Personal Information except as is necessary for performance of obligations under this Agreement or otherwise required by law. The CONSULTANT shall protect, according to reasonable industry standards, the privacy and security of any Personal Information to which CONSULTANT has access in connection with this Agreement and shall not disclose such non-public Personal Information to any third party or government agency, including federal immigration enforcement agents, unless required by this Agreement or by State or federal law.

4. Except as expressly set forth in this Amendment, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.


