#### RESOLUTION NO.

#### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OCEANSIDE, CALIFORNIA, APPROVING ANIMAL SERVICES LICENSE RATES AND FEE ADJUSTMENTS

WHEREAS, the City is responsible to ensure the enforcement of laws, ordinances and regulations of the State of California and of the City of Oceanside for regulating, licensing, impounding and disposition of dogs, cats and other domesticated animals within the City.

WHEREAS, to ensure the proper humane and efficient regulating of the handling, ownership, treatment and disposition of dogs, cats and other animals, and to ensure the enforcement of laws, ordinances and regulations, the City contracts with the San Diego Humane Society and S.P.C.A. to provide these animal control services and to collect license and fees associated with performing these services.

WHEREAS, as part of the compensation for providing these animal control services, the Humane Society and S.P.C.A. may retain all license and fees collected as part of the animal control contract.

WHEREAS, the City is responsible for setting the license rates and fees and these license rates and fees were last adjusted July 1, 2023.

NOW, THEREFORE, the City Council of the City of Oceanside does resolve as follows:

SECTION 1. The following adjustments to license rates and fees are approved with an effective date no earlier than September 1, 2025:
