CITY OF OCEANSIDE <u>AMENDMENT TO</u> PROFESSIONAL SERVICES AGREEMENT

PROJECT: ELECTRIC VEHICLE SHUTTLE SERVICE PILOT PROGRAM

THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (hereinafter "Amendment"), dated ______, 20__ for identification purposes, is made and entered into by and between the CITY OF OCEANSIDE, a municipal corporation, hereinafter designated as "CITY", and <u>Circuit</u>, hereinafter designated as "CONSULTANT."

RECITALS

WHEREAS, City and Consultant are the parties to that certain Professional Services Agreement dated <u>May 24, 2023</u>, hereinafter referred to as the "Agreement", wherein Consultant agreed to provide certain services to the City as set forth therein;

WHEREAS, the g'Oside electric vehicle shuttle program has been operating since June 2023 using a combination of SANDAG grant funds, Visit Oceanside contribution and General Fund reserves;

WHEREAS, the Agreement is currently only effective until June 30, 2025, and approximately \$180,000 in unused funds remain in the g'Oside budget and the City wishes to continue operating the program until all the funds are spent; and

WHEREAS, the parties desire to amend the Agreement to provide for changes and/or modifications to the <u>timing requirements</u>, extending the term of the Agreement an additional six months.

AMENDMENT

NOW, THEREFORE, the parties hereto do mutually agree that the Agreement shall be amended as follows:

1. Section 8, "Timing Requirements" will modify the final sentence to read "All work shall be completed in every detail to the satisfaction of the CITY by December 31, 2025."

2. Except as expressly set forth in this Amendment, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.
