2 RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 OCEANSIDE, ACTING AS THE LEGISLATIVE BODY OF CITY OF
4 OCEANSIDE COMMUNITY FACILITIES DISTRICT NO. 2022-1
5 (PUBLIC SAFETY SERVICES), ACCEPTING A UNANIMOUS
6 CONSENT AND APPROVAL OF THE PROPERTY OWNER TO
ANNEX PROPERTY TO CITY OF OCEANSIDE COMMUNITY
FACILITIES DISTRICT NO. 2022-1 (PUBLIC SAFETY SERVICES)

7 WHEREAS, the City of Oceanside (the "City") has established "City of Oceanside
8 Community Facilities District No. 2022-1 (Public Safety Services)" ("Community Facilities District
9 No. 2022-1" or the "District") pursuant to the Mello-Roos Community Facilities Act of 1982, as
10 amended, commencing with Section 53311 of the Government Code (the "Act"); and

11 WHEREAS, on November 2, 2022, the City Council, acting as the legislative body of the
12 District, adopted Resolution No. 22-R0741-1 (the "Resolution of Intention") as provided in Section
13 53339.3 of the Government Code of the State of California, to identify the territory described in
14 Attachment "A" to the Resolution of Intention (the "Annexation Area") as territory which may be
15 annexed to the District, in whole or in part, in the future upon the execution and delivery of a
16 unanimous approval of the owner or owners of each parcel or parcels to be annexed; and

17 WHEREAS, Community Facilities District No. 2022-1 has been established through the
18 adoption by the City Council of the City of Oceanside (the "City Council") of Resolution No. R0798-
19 1 (the "Resolution of Formation") on December 7, 2022 for the purpose of financing the Services
20 (the "Services") and the incidental expenses to be incurred in connection with financing the Services
21 and forming and administering the District (the "Incidental Expenses"), as described in the
22 Resolution of Formation; and

23 WHEREAS, a property owner (the "Owner") owns property located within the Annexation
24 Area which is described in Attachment "A" hereto (the "Property") and the Owner has requested that
25 the portion of the Property that they own within the Annexation Area be annexed to the District; and

26 WHEREAS, the Owner has executed and delivered to the District a Unanimous Consent and
27 Approval requesting and approving the annexation of the Owner's property to the District in

1 accordance with the Act, the Resolution of Intention and the Resolution of Formation (the
2 “Unanimous Consent and Approval”); and

3 WHEREAS, the Unanimous Consent and Approval requests and approves the levy of a
4 special tax in accordance with the rate and method of apportionment of special tax for the District
5 (the “Rate and Method”); and

6 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF OCEANSIDE HEREBY
7 FINDS, DETERMINES, RESOLVES, AND ORDERS AS FOLLOWS:

8 **Section 1.** Each of the above recitals is true and correct.

9 **Section 2.** The property to be annexed to the District has the legal description described
10 in Attachment A hereto.

11 **Section 3.** The City Council hereby finds that the Unanimous Consent and Approval
12 executed and delivered by the Owner satisfy the requirements under Sections 53329.6 and 53339 et
13 seq. and 53350 of the Act. The City Council hereby accepts the Unanimous Consent and Approval
14 executed and delivered by the Owner. The City Council hereby determines that the Property is
15 annexed to and added to Zone B of the District with full legal effect.

16 **Section 4.** The City Council is hereby authorized to levy on the land annexed to the
17 District the special tax in each fiscal year in accordance with the Rate and Method for the purposes
18 described in the Resolution of Formation.

19 **Section 5.** The Clerk is hereby directed to record in the Office of the County Recorder
20 within fifteen days of the date hereof an amendment to the notice of special tax lien for the District,
21 in the form required by Streets and Highways Code Section 3117.5. The Clerk and other appropriate
22 officers of the District are authorized to make all necessary revisions, additions and deletions to the
23 amendment to the notice of special tax lien as necessary to finalize such notice for recordation.

24 **Section 6.** This Resolution shall be effective upon its adoption.
