## CITY OF OCEANSIDE <u>AMENDMENT 1 TO</u> PROFESSIONAL SERVICES AGREEMENT

## AMENDMENT

NOW, THEREFORE, the parties hereto do mutually agree that the Agreement shall be amended as follows:

- 1. Section 1, SCOPE OF WORK, is hereby amended to increase and include to the work as follows:
  - A. Evaluation of four (4) alternative options
    - i. Option I Continued Operation of the existing facilities ii. Option 2 An alternate site with existing infrastructure for renovation iii. Option 3 A new facility to replace the existing facilities iv. Option 4 New facilities in addition to maintaining the existing facilities
  - B. Develop Cost Analysis associated with each of the four (4) site scenarios
  - C. Three (3) Community Outreach meetings
  - D. One (1) City Council Meeting
    Project Consulting Services for Police Facilities Needs Assessment
- 2. Section 8, COMPENSATION, is hereby amended to provide that the total compensation for all work performed in accordance with this amendment shall not exceed \$128,250, and for total compensation under the Agreement not to exceed \$149,825.
- 3. Except as expressly set forth in this Amendment, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.
