CITY OF OCEANSIDE <u>AMENDMENT 1 TO</u> PROFESSIONAL SERVICES AGREEMENT

PROJECT: INFOSEND PRINT AND DISTRIBUTION SERVICES

THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (hereinafter "Amendment"), dated June 4, 2025 for identification purposes, is made and entered into by and between the CITY OF OCEANSIDE, a municipal corporation, hereinafter designated as "CITY", and Infosend, Inc., hereinafter designated as "CONSULTANT."

RECITALS

WHEREAS, City and Consultant are the parties to that certain Professional Services Agreement dated May 22, 2022, hereinafter referred to as the "Agreement", wherein Consultant agreed to provide certain services to the City as set forth therein;

WHEREAS, City and Consultant wish to extend the term of the Agreement by one year pursuant to the original terms in the Agreement with a Consumer Price Index (CPI) increase to the City as set forth therein;

AMENDMENT

NOW, THEREFORE, as set forth herein, the parties hereto do mutually agree that the Agreement shall be amended as follows:

1. TERM

The term of the agreement is extended by one year from May 31, 2025 to May 31, 2026.

2. COMPENSATION

7.0 is amended to CONSULTANT'S compensation for all materials and services provided is adjusted based on the Consumer Price Index (CPI) increase from May 2022 to January 2025 for All Items San Diego- Carlsbad and is 11.2 percent and will be applied to per item charges (EXHIBIT A).

On an annual basis, CONSULTANT may request materials cost adjustment when extraordinary inflation occurs. Extraordinary inflation will be measured at a 30 percent increase over the previous period. CONSULTANT has requested extraordinary cost adjustment for specific envelope materials which had an extraordinary cost increase in the previous period (EXHIBIT A). A contingency cost of \$25,000 is established for extraordinary inflation of materials.

INFOSEND PRINT AND DISTRIBUTION SERVICES

A 10 percent increase to postage has been factored into the contract costs due to USPS's policy for rate changes in January and July of each year. All postage for this agreement will be paid by Infosend and itemized on the monthly billing to the CITY.

Bsased on historical and projected volumes and postage increases, compensation during the one-year term is estimated at \$442,275: Infosend Services \$79,500, Materials \$27,500, Postage and Delivery \$310,275, Contingency \$25,000.

3. Except as expressly set forth in this Amendment, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.

<u>SIGNATURES</u>. The individuals executing this Amendment represent and warrant that they have the right, power, legal capacity and authority to enter into and to execute this Amendment on behalf of the respective legal entities of the CONSULTANT and the CITY.
