A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
OCEANSIDE ESTABLISHING CERTAIN TRAFFIC CONTROLS  
WITHIN THE CITY OF OCEANSIDE

(Preferential Parking Permit Program for Rancho Pacifica Neighborhood)

WHEREAS, the City Council of the City of Oceanside finds the public health, safety, and welfare will be benefited by establishing certain traffic controls on particular streets within the City of Oceanside.

NOW, THEREFORE, the City Council of the City of Oceanside does resolve as follows:

SECTION 1. There is established a "No Parking – 8:00 p.m. to 8:00 a.m. / Everyday / Permit Only" zone on both sides of the following streets as allowed by Ordinance No. 21-ORO309-1:

- a) Old River Street
- b) Shasta Court
- c) Kern Court
- d) Klamath Street
- e) Trinity Street
- f) Salinas Street
- g) Mattole Street
- h) San Joaquin Street
- i) Navarro Street
- j) Avenida Descanso between Old River Street and North River Road.

SECTION 2. Staff is directed to effect the foregoing controls as soon as possible.

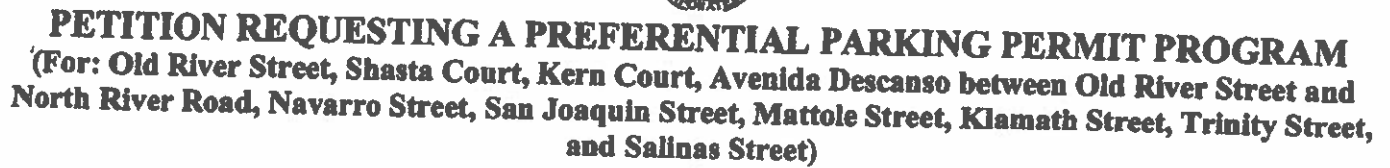
