A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OCEANSIDE APPROVING AN AGREEMENT WITH THE COUNTY OF SAN DIEGO FOR \$65,000 FOR THE REGIONAL REALIGNMENT RESPONSE GROUP (R3G) FOR FISCAL YEAR 2025.

WHEREAS, the San Diego County Sheriff's Department received funds from the Community Corrections Partnership (CCP) to create the R3G to support CCP's public safety goal; and

WHEREAS, the multi-agency R3 group will use the funds to develop and implement a targeted, proactive, intelligence-based approach to control and counteract the risks associated with realigned offenders released into San Diego County; and

WHEREAS, in support of the R3G mission, law enforcement agencies will provide enhanced enforcement by increasing patrol presence in areas where offenders are known to reside and frequent and in jurisdictions where they have been released. The patrol presence will include fourth waiver searches, directed patrols, probation compliance checks, and coordinated multi-agency sweeps; and

WHEREAS, the R3G program, implemented in December 2013, uses a targeted, intelligence-based approach to proactively address the risks posed by realigned offenders, including increased patrol presence, probation compliance checks, fourth waiver searches, and coordinated multi-agency operations; and

WHEREAS, the County of San Diego Board of Supervisors, on January 7, 2014, authorized the San Diego County Sheriff's Department to execute contracts for reimbursing participating agencies for overtime expenses incurred through R3G enforcement activities; and

WHEREAS, the County of San Diego extended the R3G agreement for Fiscal Year 2025 (July 1, 2024 through June 30, 2025), with an option for annual renewals contingent upon available funding; and

WHEREAS, the Oceanside Police Department (OPD) has been allocated \$65,000 for Fiscal Year 2025 to support R3G-related enforcement operations, including overtime patrols and operations designed to enhance public safety; and

1 WHEREAS, the OPD will utilize these funds for overtime details aimed at supporting the
2 R3G mission of managing the risks associated with realigned offenders and enhancing public
3 safety in the City of Oceanside, and will submit reimbursement forms as required under the
4 agreement.

5 NOW, THEREFORE, the City Council of the City of Oceanside does hereby resolve
6 as follows:

7 SECTION 1. The City Council hereby approves an agreement with the County of San
8 Diego for \$65,000 for the Regional Realignment Response Group for Fiscal Year 2025, to be
9 used for overtime costs associated with enforcement activities, including fourth waiver
10 searches, compliance checks, and other measures designed to enhance public safety.

11 SECTION 2: The City Council approves the reimbursement budget as outlined in the
12 staff report under the Fiscal Impact section, and directs that funds be appropriated as they are
13 received to the Oceanside Police Department for implementation of R3G objectives.

14 SECTION 3: The City Manager, Police Chief, and/or their designees are hereby
15 authorized to sign and execute on behalf of the City Council the attached agreement for the
16 Regional Realignment Response Group for Fiscal Year 2024-2025, including all related
17 documentation.

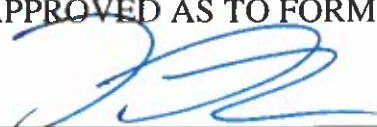
