

**CITY OF OCEANSIDE
AMENDMENT 4 TO
PROFESSIONAL SERVICES AGREEMENT**

PROJECT: Measure X, District Tax, Sales and Use Tax Services

THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (hereinafter "Amendment"), dated April 10, 2026 for identification purposes, is made and entered into by and between the CITY OF OCEANSIDE, a municipal corporation, hereinafter designated as "CITY", and Hinderliter de Llamas and Associates, a California Corporation, hereinafter designated as "CONSULTANT."

RECITALS

WHEREAS, City and Consultant are the parties to that certain Professional Services Agreement dated April 10, 2019, hereinafter referred to as the "Agreement", wherein Consultant agreed to provide certain services to the City as set forth therein;

WHEREAS, City and Consultant are the parties to Amendment 1 of the Professional Services Agreement dated April 10, 2019 wherein the term of the Agreement is extended by one year to April 10, 2023.

WHEREAS, City and Consultant are the parties to Amendment 2 of the Professional Services Agreement dated April 10, 2019 wherein the term of the Agreement is extended by one year to April 10, 2024.

WHEREAS, City and Consultant are the parties to Amendment 3 of the Professional Services Agreement dated April 10, 2019 wherein the term of the Agreement is extended by two years to April 10, 2026.

WHEREAS, The Parties now desire to amend the Agreement for ongoing consultation to extend the contract term for Transaction Tax Services for Measure X for one year, until April 10, 2027, with one additional one-year option to extend administratively until April 10, 2028.

AMENDMENT

NOW, THEREFORE, the parties hereto do mutually agree that the Agreement shall be amended as follows:

1. The term of the agreement is extended one year until April 10, 2027, with one additional one-year option to extend administratively until April 10, 2028, subject to annual review and recommendation of the Director of Financial Services.

2. The Consultant's compensation shall be \$3,600 for year one. If the option to extend is exercised, the compensation for year two shall be \$3,600, subject to increase based on the Consumer Price Index for All Urban Consumers (CPI-U) as reported by the U.S. Bureau of Labor Statistics.

3. Except as expressly set forth in this Amendment, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.


SIGNATURES. The individuals executing this Amendment represent and warrant that they have the right, power, legal capacity and authority to enter into and to execute this Amendment on behalf of the respective legal entities of the CONSULTANT and the CITY.
