

**CITY OF OCEANSIDE****AMENDMENT 1 TO

THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (hereinafter "Amendment"), dated \_\_\_\_\_ 20\_\_\_\_, for identification purposes, is made and entered into by and between the CITY OF OCEANSIDE, Water Utilities Department, a municipal corporation, hereinafter designated as "CITY", and KRD MANAGEMENT CONSULTING, LLC., hereinafter designated as "CONSULTANT."

**RECITALS**

WHEREAS, CITY and CONSULTANT are the parties to that certain Professional Services Agreement dated April 23, 2026, hereinafter referred to as "Agreement", wherein CONSULTANT agreed to provide certain services to the CITY as set forth therein;

WHEREAS, the parties desire to amend the Agreement to extend the term of the agreement with modified compensation.

**AMENDMENT**

NOW, THEREFORE, the parties hereto do mutually agree that the Agreement shall be amended as follows:

1. Section 7, Compensation, shall be amended to reflect that all work performed in accordance with Amendment 1 shall not to exceed cost of \$1,029,600 for a total contract amount of \$1,129,600.
2. Section 9, Timing Requirements, shall be amended to reflect that all work shall be completed in every detail to the satisfaction of the CITY by June 30, 2029.
3. Except as expressly set forth in this Amendment, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.
