

ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF  
OCEANSIDE, CALIFORNIA, AMENDING ARTICLE 14,  
SECTION 14 AND 14.1 OF THE OCEANSIDE TRAFFIC CODE  
BY THE ADDITION AND CHANGES OF VARIOUS SUB-  
SECTIONS TO ESTABLISH VARIOUS SPEED LIMITS ON  
VARIOUS STREETS

WHEREAS, the City of Oceanside establishes speed limits on public streets based on criteria set forth in the California Vehicle Code and California Manual on Uniform Traffic Control Devices, and enforced in the San Diego Superior Court, North County District, Vista Traffic Court regarding posted speed limits on public streets.

NOW THEREFORE, the City Council of the City of Oceanside, California, does ordain as follows:

SECTION 1. Article XIV, Section 14.1, Subsection (21a-21d) of the Oceanside Traffic Code are hereby amended to delete Subsection "(21a-21d)" and replace with:

"(21a) Reserved"

"(21b) Douglas Drive between North El Camino Real and North River Road --- 40 mph"

"(21c) Douglas Drive between North River Road and Catalina Drive --- 40 mph"

"(21d) Douglas Drive between Catalina Drive and Via Malaguena --- 50 mph"

"(21e) Douglas Drive between Via Malaguena and Vandergrift Boulevard --- 45 mph"

SECTION 2. Article XIV, Section 14.1, of the Oceanside Traffic Code are hereby amended to read:

"(33) Shadowridge Drive between Cannon Road and Southerly City Limits --- 30 mph"

SECTION 3. Article XIV, Section 14.1, Subsection (35) of the Oceanside Traffic Code are hereby amended to delete Subsection "(35)" and replace with:

"(35) Reserved"

SECTION 4. Article XIV, Section 14.1, of the Oceanside Traffic Code are hereby amended to read:

"(38) North El Camino Real between Douglas Drive and Peyri Drive --- 25 mph"

1       SECTION 5. Article XIV, Section 14.1, Subsection (47) of the Oceanside Traffic Code  
2 are hereby amended to delete Subsection “(47)” and replace with:

3       “(47a) Melrose Drive between Oceanside Boulevard and Sagewood Drive --- 45 mph”

4       “(47b) Melrose Drive between Sagewood Drive and North Santa Fe Avenue --- 45 mph”

5       SECTION 6. Article XIV, Section 14.1, of the Oceanside Traffic Code are hereby  
6 amended to read:

7       “(51) Industry Street between El Camino Real and Camelot Drive --- 25 mph”

8       “(62) Darwin Drive between Glenhaven Drive and Sunridge Drive --- 25 mph”

9       “(74) Los Arbolitos Boulevard between El Camino Real and Pala Road --- 25 mph”

10       “(85) Rancho Del Oro Road between Oceanside Boulevard and Mesa Drive--- 45 mph”

11       SECTION 7. Article XIV, Section 14.1, of the Oceanside Traffic Code are hereby  
12 amended to add Subsection “(90)” to read:

13       “(90) Mission Gate Drive between Mission Avenue and Via Rancho Road --- 25 mph”

14       SECTION 8. This ordinance shall be codified in the Oceanside Traffic Code.

15       SECTION 9. The provisions of this ordinance shall be effective thirty days following its  
16 adoption. Within fifteen days following its adoption, the City Clerk shall publish this ordinance  
17 in the San Diego Union, a newspaper of general circulation in the City of Oceanside.

18       SECTION 10. Severability.

19       If any section, sentence, clause or phrase of this Ordinance is for any reason held to be  
20 invalid or unconstitutional by a decision of any court of competent jurisdiction, such decision  
21 shall not affect the validity of the remaining portions of this Ordinance. The City Council  
22 hereby declares that it would have passed this ordinance and adopted this Ordinance and each  
23 section, sentence, clause or phrase thereof, irrespective of the fact that any one or more  
24 sections, subsections, sentences, clauses or phrases be declared invalid or unconstitutional.
