AMENDMENT 1 TO
PROFESSIONAL SERVICES AGREEMENT

**PROJECT: ON CALL ENVIRONMENTAL ENGINEERING SERVICES FOR
WATER UTILITIES CAPITAL IMPROVEMENT PROJECTS**

THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (hereinafter "Amendment"), dated _____ 20____, for identification purposes, is made and entered into by and between the CITY OF OCEANSIDE, Water Utilities Department, a municipal corporation, hereinafter designated as "CITY", and DUDEK, hereinafter designated as "CONSULTANT."

RECITALS

WHEREAS, CITY and CONSULTANT are the parties to that certain Professional Services Agreement dated April 30, 2025, hereinafter referred to as "Agreement", wherein CONSULTANT agreed to provide certain services to the CITY as set forth therein;

WHEREAS, the parties desire to amend the Agreement to extend the term of the agreement and add compensation therefor.

AMENDMENT

NOW, THEREFORE, the parties hereto do mutually agree that the Agreement shall be amended as follows:

1. Section 7, Compensation, shall be amended to reflect that all work performed in accordance with Amendment 1 shall not exceed \$100,000 per year, for a two-year term, for a total contract price not to exceed \$300,000.
2. Section 8, Timing Requirements, shall be amended to reflect that all work shall be completed in every detail to the satisfaction of the CITY by June 30, 2028, with the possibility of two one-year extensions through June 30, 2030, at the City's sole discretion.
3. Except as expressly set forth in this Amendment, the Agreement shall remain in full force and effect and is hereby ratified and reaffirmed.

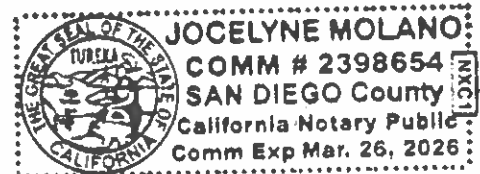
