A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
OCEANSIDE AUTHORIZING ACCEPTANCE OF \$52,914 IN
GRANT FUNDS FROM THE EDWARD BYRNE MEMORIAL
JUSTICE ASSISTANCE GRANT OF FY2024 FROM THE U.S.
DEPARTMENT OF JUSTICE

WHEREAS, the U.S. Department of Justice, Bureau of Justice Assistance provides funds
as appropriated by Congress to local jurisdictions under the Edward Byrne Memorial Justice
Assistance Grant (JAG) program to supplement frontline law enforcement services, including
funding for personnel, equipment, supplies, and services;

WHEREAS, the City of Oceanside has received JAG grant awards since its inception in
2005 to fund qualified law enforcement programs, staffing, and equipment;

WHEREAS, the JAG grant awards have supported the Oceanside Police Department's
ability to enhance public safety through quicker response times and the development of
intelligence to address criminal activities; and

WHEREAS, the Oceanside Police Department desires to accept \$52,914 from the 2024
JAG Program award to fund the purchase of nine Flock Automatic License Plate Recognition
(ALPR) cameras to be deployed within the city of Oceanside to enhance investigative efforts and
support crime suppression initiatives;

NOW, THEREFORE, the City Council of the City of Oceanside does resolve as follows:

SECTION 1. To authorize the acceptance of the 2024 JAG Program grant award of
\$52,914.

SECTION 2. Approve the grant budget and expenditure plan outlined in the staff report
and appropriate the funds to the Oceanside Police Department.
